### Cook Inlet Risk Assessment Underway

For well over a decade, the concerns about navigation risks in the Cook Inlet have simmered. The Cook Inlet Regional Citizens Advisory Council (Cook Inlet RCAC), pilots, harbor masters, and many others have voiced those concerns formally and privately, and through two separate forums sponsored by Cook Inlet RCAC on the subject of navigational hazards and risk assessments.

In October 2010, due in large part to the Council’s efforts, the United States Coast Guard’s Congressional Reauthorization included a mandate to conduct a Cook Inlet Risk Assessment.

Early this year, \$250,000 in initial funding from the State of Alaska became available through a grant from the Kenai Peninsula Borough. A Management Team was formed, consisting of Mike Munger, Executive Director of Cook Inlet RCAC; Captain Jason Fosdick, Captain of the Port, US Coast Guard; and Steve Russell, Program Manager, Alaska Department of Environmental Conservation. Nuka Research was retained to serve as Project Manager.

Shortly thereafter, an additional \$180,000 was directed to the effort through the National Fish and Wildlife Foundation. A third funding source that materialized was the Prince William Sound RCAC, which contributed an additional \$20,000. Most recently, Tesoro has now pledged \$20,000 as well.

## Risk Assessment (con't.)

Stakeholder groups were solicited in August to fill the seats of an Advisory Panel of experts with vast credentials and local knowledge. These individuals were chosen from applications received to represent commercial fishing, pilots, shipping and ports, salvors, oil producers, Alaska Natives, environmental managers and others. The Panel's first meeting was in October, and featured a presentation of the Vessel Traffic Study. It is expected the full Assessment will take up to two years and cost just under \$1 million to perform.

The Assessment will analyze the risks present to navigation in the Inlet. It will further project the nature of the consequences these risks are likely to create, and the measures necessary to reduce the likelihood of an event and to mitigate the consequences. The Advisory Panel will recommend measures to federal and state agencies and industry to achieve these goals.

# Directors Spotlight - Stanley & Opheim Take to the Sea

Carla Stanley (City of Homer) and Michael Opheim (Alaska Native Organizations) accepted an invitation from Tesoro to observe the company's recent on-water oil spill response training exercise launched from Homer. Joined by Cook Inlet RCAC staff and a number of agency and industry observers, Stanley and Opheim saw a full-blown deployment of off-shore, near-shore and shoreline recovery and containment measures, including a lightering and decon station.

Acting as the Oil Spill Response Organization, or OSRO, Cook Inlet Spill Prevention and Response, Inc. (CISPRI) devoted a great deal of attention during the drill to the deployment and evaluation of their 56 and 13 disc Crucial skimmers. CISPRI also engaged contract Vessels of Opportunity from the Homer and Seldovia commercial fishing community, as well as the Seldovia Oil Spill Team for near- and on-shore measures.

In related notes, Carla reports earning her Certificate of Achievement for successful completion of the U.S. Department of Homeland Security/FEMA Emergency Management Institute *Introduction to Incident Command System (ICS-100)* course. And Michael has been appointed to the Risk Assessment Advisory Panel. Congratulations, Michael and Carla!

# CISPRI Profile

Cook Inlet Spill Prevention and Response, Inc. (CISPRI) is having a busy year. In addition to its core activities of supporting member regulatory drill requirements, equipment maintenance and spill responder training, the oil spill recovery organization is excited about several new initiatives they are pursuing. Among these new endeavors:

- Completion and full utilization of their 18,700 gallon Test Tank. This facility will provide CISPRI and its members the ability to validate skimmer performance to the ASTM F2709 standard. In addition, CISPRI hopes to support other spill response organizations' responder training needs. Though not a wave tank, it allows for the introduction of ice, mimics the salinity of Cook Inlet, and allows responders the ability to work with real oil. The tank measures 25'x25'x4', and is located within a contained, heated concrete slab.
- Relocation of its Sea Otter Rehabilitation facility from Nikiski to Seldovia. The new facility at the Seldovia harbor will be fully operational beginning Summer 2012.
- Upgrading its Incident Command Center and planning for further technological improvements in 2012 ... including the introduction of SmartBoard technology.

These improvements are expected to enhance member use of their operations tech manual and response equipment availability and published rental rates for the Planning and Finance Sections. They will also allow several environmental enhancements, including the effective use of the ShoreZone imagery database, Geographic Information System (GIS), Geographic Response Information Network (GRIN), and the Cook Inlet RCAC Ice Forecasting Network. CISPRI views these key additions as timely steps toward keeping communication technology at the forefront.

## Coast Guard Awards Annual Recertification

The Cook Inlet RCAC is legislatively required to demonstrate on an annual basis that it is operating in accordance with its Congressional mandate under the Oil Pollution Act of 1990 (OPA 90). This thorough, very public process was initiated in June. It details our budget, and shares the status of programs undertaken to advance our mission.

In a letter dated September 14, 2011, the U.S. Coast Guard notified Cook Inlet RCAC of its successful recertification, effective through August 31, 2012. In approving our Recertification, Rear Admiral Thomas P. Ostebo commented “My staff and I look forward to continued work with you on our common goal of improving the safe and environmentally sound transportation of oil in Cook Inlet and surrounding communities.”
