Current projects include conducting a comprehensive risk assessment for oil facilities and infrastructure and ensuring detailed habitat data for all Cook Inlet area shorelines are available and integrated within the Incident Command during oil spill prevention planning and response. Our stakeholders and partners help us educate the public to enhance long-term stewardship of Cook Inlet.

Alaska ShoreZone (CIRCAC)

To become certified, your organization must have:

- activities which take place in the vicinity of Cook Inlet or Kodiak Island
- headquarters or affiliate offices located in the vicinity of Cook Inlet
- a majority of members residing in the vicinity of Cook Inlet (local chapters, if part of a national organization)
- 20 members or more
- membership meetings at least on an annual basis
- been incorporated or otherwise recognized by the State of Alaska, or be affiliated with a national organization.

About us

In the aftermath of the Exxon Valdez oil spill, Congress passed the comprehensive Oil Pollution Act (OPA) of 1990, which created two regional citizen advisory councils, Cook Inlet RCAC and Prince William Sound RCAC, to involve citizen participation in oil transportation and production. To ensure broad representation, Congress drew up the guidelines for selecting voting members. The CIRCAC Board of Directors is comprised of 13 members, each representing a specific interest or community. The cities of Anchorage, Kenai, Homer, Seldovia, and Kodiak each have a seat on the Council, as do the Kodiak Island Borough and the Kenai Peninsula Borough. Interest groups represented include Alaska Native organizations, tourism, environmental groups, recreational groups, commercial fishing groups, and aquaculture associations. Through OPA 90, we are mandated to conduct programs in biological and chemical monitoring, oil spill prevention and response, oil behavior, risk assessments, coastal habitats, physical oceanography, technical review and public outreach.

Certified Participating Groups

As prescribed by OPA 90, certified stakeholder groups are those which have chosen to support our efforts on behalf of their organization and want to be in a position of being represented, kept informed, and consulted. On a three-year, rotating basis, these groups nominate and elect a representative and an alternate. We encourage interested groups to participate in the leadership of the Council through the one-time certification process and to consider active participation on the board or committees.
