Tesoro Alaska has served the fuel transportation needs of the western United States for more than 45 years. We are a leading independent refiner and marketer of petroleum products, committed to operating responsibly in the communities we serve. Our headquarters is in San Antonio, Texas, and we operate across 18 states. Our Alaska refinery is located on the Cook Inlet, 60 miles southwest of Anchorage, and can process up to 72,000 barrels per day (bpd). The refinery produces gasoline and gasoline blendstocks, jet fuel, diesel fuel, heating oil and heavy fuel oils, propane and asphalt. The crude oil is delivered by double-hulled tankers through Cook Inlet and by pipeline from the Kenai Peninsula and Cook Inlet.
